We act as town planning consultants for Pureland Developments Pty Ltd (the Applicant) and write to lodge a Development Application for a Development Permit for Reconfiguring a Lot — Boundary Realignment of 4 lots into 4 lots — over the land described above (the Application). The Application is lodged under the *Planning Act 2016* and is assessed against the Toowoomba Regional Planning Scheme 2012 (TRPS).

The proposal seeks to rearrange the boundaries of the four existing freehold lots at 193 Donovan Road, Cabarlah into four reconfigured lots, in accordance with the supporting Boundary Realignment Plans prepared by K. J. Wilson, Cadastral Surveyor. The realignment results in no net increase in the number of lots. The new boundaries rationalise existing cadastral boundaries to better reflect existing fence lines and land use, consolidate vegetated and constrained land into a single balance lot, and improve the relationship between the existing dwelling sites and their respective landholdings. No new dwellings, structures or operational works are proposed as part of this Application.

The following documents are enclosed with this Application:

1. DA Form 1 — Development Application Details;
2. Owner's Consent (Company);
3. Planning Report prepared by Novus Urban;
4. Supporting Boundary Realignment Plans prepared by K. J. Wilson, Cadastral Surveyor and Tree Plot Contour and Detail; and
5. Receipt of Payment of Impact Assessment Fees.

The Application is impact assessable under the TRPS by reason that the resulting lots do not meet the minimum lot size of 100 hectares applicable in the Rural Zone (100ha Precinct). Notwithstanding this assessment pathway, we respectfully submit that the Application is straightforward in its nature and merits, and that a comprehensive response to all applicable assessment benchmarks has been provided in the accompanying Planning Report.

We are hopeful that Council will be in a position to progress the Application directly to a decision without the need to issue an Information Request or Advice Notice. The Application has been comprehensively prepared following a pre-lodgement meeting with Council (reference

PREL/2026/4067, held 8 June 2026), and the Planning Report is structured to directly address all matters raised at that meeting. We trust that the supporting material provided is sufficient for Council to assess the Application on its merits and issue an approval with standard conditions.

Given the mild nature of the development proposed — a boundary rearrangement of four rural lots into four rural lots with no additional lots created, no new dwellings or operational works, and no material change to land use — we respectfully request that Council permit the Applicant to commence upfront public notification from the date of receipt of the Confirmation Notice. We consider this approach to be efficient and consistent with the intent of the statutory process, and it is offered in good faith to facilitate the earliest possible progression of the Application.
