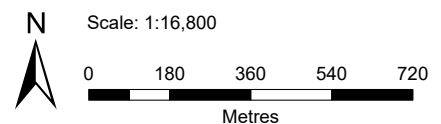




Regulated vegetation management map (Category A and B extract)

Category B on the regulated vegetation management map

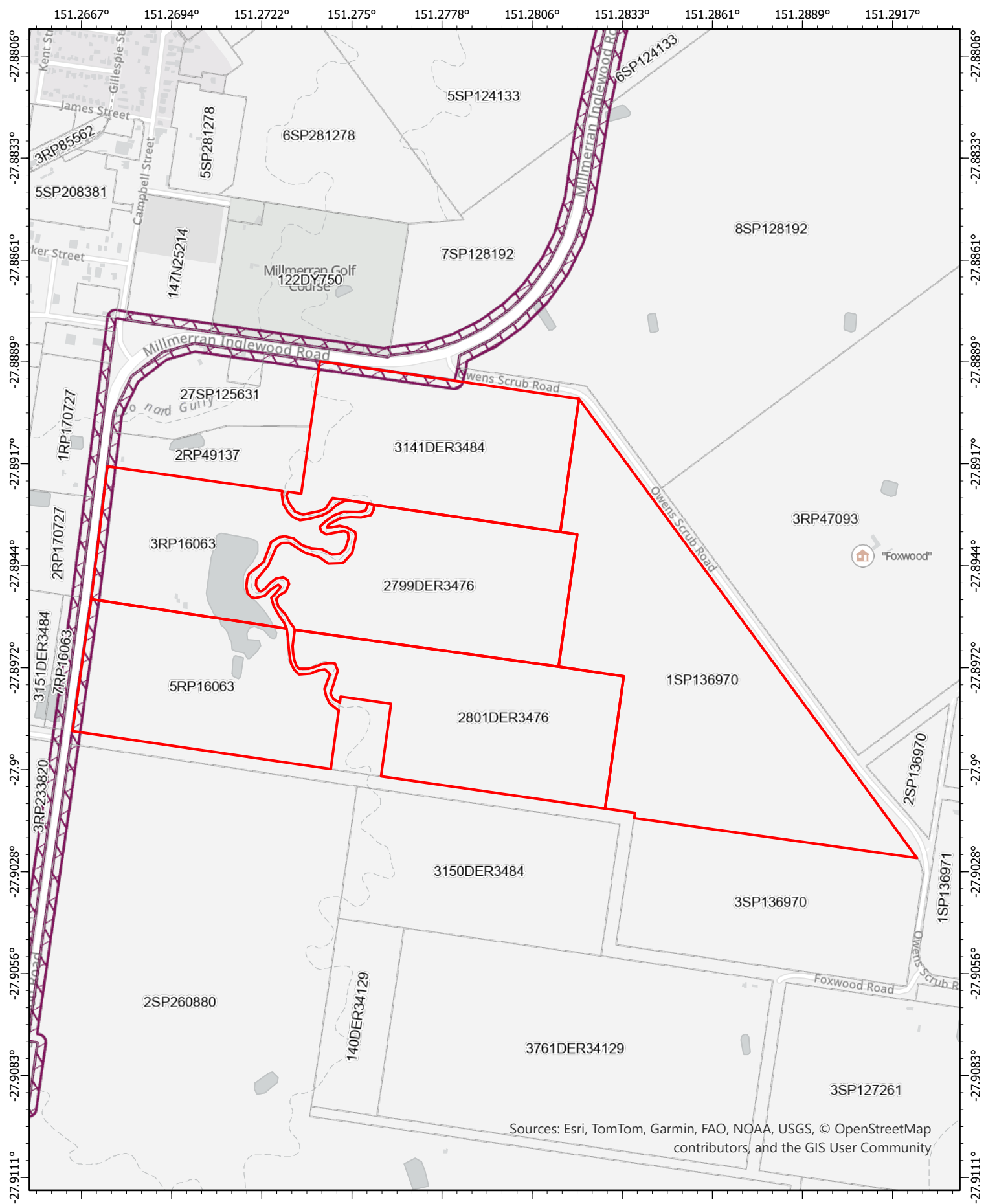

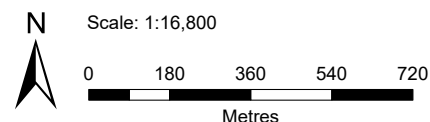




 Area within 25m of a State-controlled road

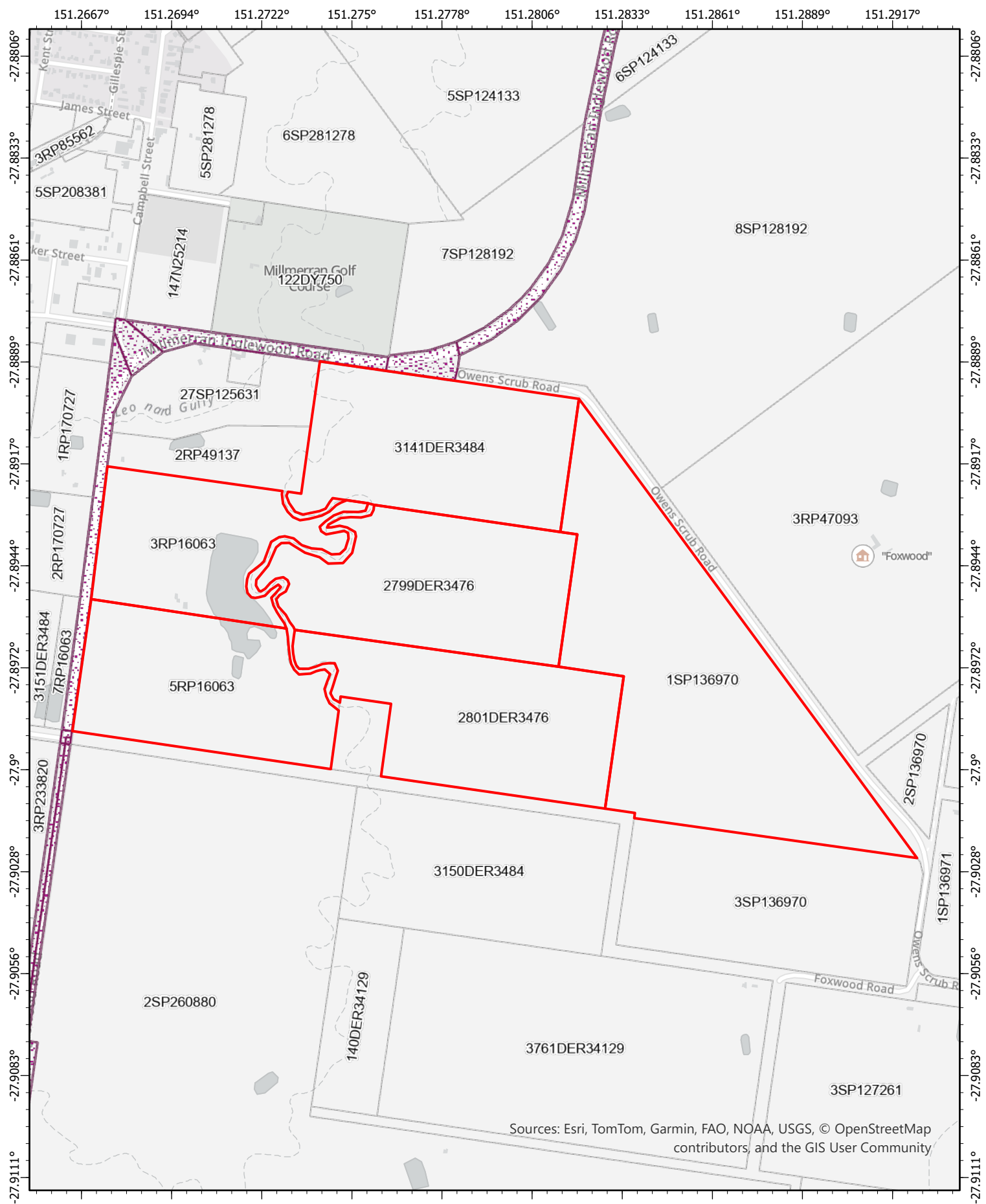

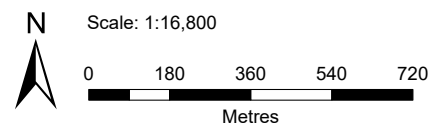
