This petition is from: Residents of Meringandan and surrounding areas.

The petition draws to Council's attention: Development Application RAL/2025/5992 for a proposed residential subdivision in Meringandan. The proposal conflicts with the Highfields, Meringandan and Meringandan West Local Plan Code, which encourages only minor expansion of the township and requires development in the Township Expansion Area to reflect existing community character and urban form. The proposed density—predominantly 300–500 m² lots—is inconsistent with the established character of Meringandan. The scale and pattern of development would not strengthen or consolidate the existing community but instead replace its character, contrary to the Local Plan intent. Approval would undermine community expectations, planning certainty, and the integrity of the Planning Scheme.

We therefore request Council to: Refuse Development Application RAL/2025/5992 in its current form; or impose a minimum lot size of 667 m² to ensure development aligns with the Local Plan and community character. The facts and circumstances in support of this position are detailed in the letter to Council prepared by Rebecca Reid.
